So as to prove that the President(s) of Brazil and the Ministers of the Supreme Court of Brazil, U.S. Department of State, U.S. Department of Justice, Drug Enforcement Agency and these agencies employees and my past Attorney Charles W. up the fact that I was tortured and the facts surrounding the torture an implantation of brain control implants/Parametric Cavities into my body at the Brazilian Federal Police Station in Brasilia, Brazil the capital of Brazil. I am providing you the following documents:

- 1. February 12, 1996, letter from Maxime Toscanino, Reg. No. 08126-069. Federal Correction Institution Fort Dix, P.O. Box 2000, Fort Dix, N.J. 08640, to John Gregory Lambros & Attorney Jeff Orren.
- 2. October 20, 1991, Sunday Newspaper article from CAMPINAS, entitled "MAFIOSO DA CAMORRA PRESO TORTURAS NA DITADURA" by JOSE FRANCISCO PACOLA. The article offers a picture of Francesco Toscanino and history of his case.
- 3. <u>U.S. vs. LAMBROS</u>, 65 F.3d 698, pages 700, 701, & 702. Please note that I have underlined sentences in the third paragraph of pages 701 and West Key note #7 on page 702.

The Eighth Circuit Court of Appeals stated in their above-entitled judgement, <u>U.S. vs. LAMBROS</u>, that my [Lambros'] testimony which claims that I had been tortured was unreliable because defendant [Lambros] perjured himself in other regards at trial and because testimony was <u>FANTASTIC</u>. (For instance, Lambros maintains that he was held in the same Brazilian cell where the mistreatment alleged in <u>UNITED STATES</u> <u>vs. TOSCANINO</u>, 500 F.2d 267 (2nd Cir. 1974), occurred, and <u>even</u> <u>asserts that he MET TOSCANINO THERE.</u>)

The attached newspaper article which appeared in the Sunday, October 20, 1991, CAMPINAS, PROVES THAT FRANCESCO TOSCANINO WAS HELD IN THE SAME BRAZILIAN FEDERAL POLICE STATION I WAS. In fact, the facility only has seven (7) or eight (8) cells. THUS, MY TESTIMONY TO THE DISTRICT COURT, JUDGE MURPHY, WAS NOT FANTASTIC. The U.S. Department of Justice, U.S. Department of State, U.S. Drug Enforcement Agency, specifically Agent Terryl Anderson and Aubrey Sue and the Brazilian Government willfully conspired to cover-up the information.

Maxime Toscanino, the son of Francesco Toscanino, stated in his letter that his father is presently incarcerated in a maximum security prison near Naples, Italy. If it wasn't for Attorney Orren, a friend of the Lambros family, and the telephone calls and letters we wrote to the addresses Francesco Toscanino gave me while we spent close to five (5) months togeather within the same Brazilian Federal Police Station, this information would of never been revealed. Again my court appointed attorney Charles W. Faulkner and Colia Ceisel, DEA agents in Brazil who testified at my trial, U.S. Department of State General Counsel Margaret Murphy who refused to obey U.S. Federal Judge D. Murphys' SUBPOENA to TESTIFY at my trial and the daily lies and refusals of U.S. Assistant Attorney Douglas Peterson to investigate the true information I offered as to my daily torture have prevented and covered-up the truth of my daily torture and implantation in BRAZIL.

By copy of this letter, I am requesting Attorney Dr. Julio Cardella, Francesco Toscaninos' attorney, to send an AFFIDAVIT as to the dates Francesco Toscanino was incarcerated/detained at the Brazilian Federal Police Station in Brasilia, Brazil to Attorney Jeff Orren, address is located below mine, with copy to Senator Jesse Helms.

I would request same from the President of Brazil, Fernando Henrique Cardoso, but as to date he has not responded to any of my letters and must be to involved in running his banana republic or trading slaves.

Also I am requesting Maxime Toscanino to send an AFFIDAVIT as to:

- 1. The current location of his father Francesco Toscanino.
- 2. The date of Francesco Toscanino was arrested in Brazil in 1991.
- 3. The name of the government agency that arrested Francesco Toscanino in Brazil and name of the agents.
- 4. The names and addresses and dates of the locations Francesco Toscanino was incarcerated/detained in during his extradition proceedings to Italy in 1991.
- 5. The date Francesco Toscanino was extradited to Italy in 1991 or 1992.
- 6. Francesco Toscaninos' attorney(s) name(s), address, telephone and fax number and E-Mail address in Italy that currently represent him.
- 7. Information as to the Court Francesco Toscanino appeared before in Italy due to his extradition from Brazil in 1991 or 1992. Case number, judge(s) names, etc. requested.

Please mail the above information U.S. Certified Mail to Attorney Orren and request others to contact him with information via my E-Mail address on the American Online: BrazilByct@aol.com Copy should also be sent to Senator Jesse Helms.

Also I am requesting Francesco Toscanino to respond to the above information in AFFIDAVIT form, if possible due to his current prison and health conditions, to Attorney Orren with copy to Senator Jesse Helms.

The last and possibly the most important question I have is if Francesco Toscanino is also a VICTIM OF IMPLANTATION, as I could hear his screams at night when the electricity is turned up in the cell block and the psychic driving is intensified at the Federal Police Station in Brasilia, Brazil. Remember the U.S. Army Corps of Engineers designed

and assisted in the construction of the "DEPATTERENING CELL(s)" within the Brazilian Federal Police Station, Brasilia, Brazil in the late 1960's, and may of used the technology on Francesco Toscanino during the 17 days he was tortured and interrogated as a member of the United States Department of Justice, Bureau of Narcotics and Dangerous Drugs was present at one or more intervals and actually participated in portions of the interrogation... U.S. vs. TOSCANINO, 500 F.2d 267, 270, in January 1973. The CIA has released information as to the use of such technology in Project MKULTRA and it contracted same with the Bureau of Narcotics and Dangerous Drugs.

PURVIS CARTWRIGHT, past U.S. Army Intelligence has given statements to my current attorney Colia Ceisel as to teaching of Brazilian Government officials how to use the "DEPATTERNING CELL(s)" and how to implant humans for torture, interrogation and tracking. Affidavits have been submitted as to Cartwrights statements to the U.S. District Court in Minnesota, U.S. Assistant Attorney Douglas Peterson, Attorney Colia Ceisel, U.S. Senators, and FBI Special Agent Stephen A. Gilkerson, Suite 1100, 111 Washington Avenue South, Minneapolis, Minnesota 55401, who has refused to visit Purvis Cartwright, inmate number #59478-079, who is presently incarcerated at the U.S. Bureau of Prisons facility Florance, Colorado, so he may access Cartwrights' military records, which have now been sealed, as to his professional training in the art of torture interrogation, implantation of humans, use of the "DEPATTERNING CELL", etc. Cartwright was stationed in Brasilia, Brazil in the late 1960's and lived at the U.S. Embassy in Brasilia, Brazil while he trained Brazilian Officials, French and Russian military officials. Cartwright also explained the tracking radar that was installed in Brasilia, Brazil to track humans to attorney Ceisel.

Maxime Toscanino may want to send his father a copy of LOBUE vs. CHRISTOPHER, 893 F. Supp. 65 (D.D.C. 1995) which ORDERED the U.S. Extradition Treaty UNCONSTITUTIONAL, due to seperation of power between the justice dept. and the dept. of state as the same may apply in Italy. President Cardoso has chosen not to respect the Courts ORDER and continued to extradite U.S. Citizens to the United States. Maybe be can't read my letters and copy of court documents that he was served with. Interesting is the fact President Cardoso assisted in the drafting of the 1988 Brazilian Constitution, something he obviously does not respect or a senile cataract prevents him from reading same.

The above information and documents attached to this letter will act as proof as to the need to call a Senate Subcommittee Investigation as to the torture and forced implantation of John Gregory Lambros.
